MORE MONEY FOR SCHOOLS, NOT SO MUCH FOR PENSIONS, NEW JERSEY VOTERS TELL QUINNIPIAC UNIVERSITY POLL; SUPPORT FOR MILLIONAIRE'S TAX TOPS 3-1

New Jersey voters are solidly behind spending more money to improve the Garden State's public schools, but send mixed messages on the subject of funding public employee pensions, according to a Quinnipiac University poll released today.

The State Legislature should spend more money to improve <u>all</u> of New Jersey's public schools, voters say 63 – 34 percent, the independent Quinnipiac (KWIN-uh-pe-ack) University poll finds.

By a similar 65 - 32 percent, voters say the State Legislature should spend more to improve public schools in the state's poorest districts. Republicans oppose increased spending 59 - 40 percent and white men are divided 49 - 47 percent. Every other party, gender, racial, age and education group listed supports the spending by wide measures.

Voters support 62 - 30 percent the State Supreme Court decision ordering the State Legislature to spend more money to improve public schools in the state's poorest districts. Again, Republicans oppose the court decision 59 - 30 percent and white men are divided 47 - 46 percent, while all other groups support the court decision.

The state should provide poor school districts additional funds per student, 58 percent of New Jersey voters say, while 37 percent say <u>all</u> districts should get the same amount of funding.

"New Jerseyans don't like taxes, but they do like school kids. Almost two-thirds want to spend more money for school kids – not just poor kids, but <u>all</u> kids," said Maurice Carroll, assistant director of the Quinnipiac University Poll.

"Was the State Supreme Court – much criticized by politicians for the Abbott decisions that give more of the state education money to poor schools – right? Yes, voters say."

New Jersey voters support 74 - 22 percent, with Republicans divided 48 - 49 percent, a so-called "millionaire's tax," with the money going to public schools.

By a similar 70 - 27 percent, voters support a "millionaire's tax" with the money going to public employee pensions. Republicans oppose this idea 55 - 42 percent.

Voters oppose 66 - 30 percent an across-the-board tax hike to help fund public employee pensions. Democrats oppose this idea 56 - 41 percent, with every other listed group opposed.

But in a different question, New Jersey voters say 49 - 45 percent that the state has an obligation to fix public employee pensions, even if it means raising taxes. Republicans oppose this idea 62 - 31 percent. Support is 61 - 33 percent among Democrats. Independent voters are divided, with 48 percent saying there is an obligation and 44 percent saying no.

To help balance the state budget, state employees should pay more for health care, New Jersey voters say 60 - 31 percent, with support from every listed group.

But voters oppose 52 - 41 percent reducing public employee pension benefits as a way to balance the budget. Republicans support pension cuts 64 - 30 percent, with Democrats opposed 68 - 24 percent. Independent voters are divided, with 45 percent supporting cuts and 47 percent opposed.

"New Jerseyans' generosity shrinks – but it's still there – when it comes to pensions for state workers. Voters wouldn't cut pensions," Carroll said.

"How about raising taxes to fix the pension system? It depends how the question is asked.

"But there's one tax raising plan that almost everyone likes – the millionaire's tax. The Quinnipiac University Poll didn't ask what percentage of our respondents are millionaires."

From March 9 – 13, Quinnipiac University surveyed 1,098 New Jersey voters with a margin of error of +/-3 percentage points. Live interviewers call landlines and cell phones.
