# NEW JERSEY VOTERS WANT RAIL TUNNEL, BUT NO GAS TAX HIKE, QUINNIPIAC UNIVERSITY POLL FINDS; CHRISTIE APPROVAL RATING STUCK IN TRAFFIC

New Jersey voters support 53 - 37 percent building a new rail tunnel between the Garden State and Manhattan, with support from every region in the state, according to a Quinnipiac University poll released today.

Support for a new rail tunnel ranges from 47 - 44 percent among voters in the Philadelphia suburbs to 60 - 33 percent among suburban voters. Support is 62 - 30 percent among Democrats, 51 - 40 percent among independent voters and 47 - 41 percent among Republicans. Among the 11 percent of New Jersey voters who commute to New York City for work, support for the tunnel is 68 - 27 percent.

The rail tunnel is "very important" or "somewhat important" to the New Jersey-New York regional economy, 62 percent of voters say.

Voters oppose 58 - 39 percent increasing the gasoline tax to finance road and mass transit improvements, the independent Quinnipiac (KWIN-uh-pe-ack) University Poll finds.

Opposition to a gas tax hike ranges from 53 - 41 percent among voters in the Philadelphia suburbs to 62 - 35 percent among urban voters.

"Last time, Gov. Christopher Christie didn't want New Jersey to be stuck for most of the cost of a rail tunnel that 'ended in Macy's basement.' This time, voters support the tunnel and say it will be good for the economy. We'll have to see what sort of plan the governor will go for," said Maurice Carroll, assistant director of the Quinnipiac University Poll.

"The other transportation issue, how to bail out the broke transportation trust fund, crosses the double white line for a head-on collision with a cardinal rule of New Jersey politics: Don't hike the gas tax."

Opposition is 69 - 27 percent among Republicans and 59 - 39 percent among independent voters. Democrats support a tax hike 51 - 46 percent. Opposition to the gas tax hike is 54 - 46 percent among commuters and 58 - 38 percent among those who don't commute.

### Gov. Christie's Approval

New Jersey voters give Gov. Christopher Christie a mixed job approval rating, as 48 percent approve and 47 percent disapprove. This compares to a 46 – 45 percent approval rating October 1 and continues an 11-month slump which began when the Bridgegate scandal broke.

Approval is 82 - 12 percent among Republicans and 51 - 45 percent among independent voters, while Democrats disapprove 74 - 20 percent.

The governor gets negative grades for handling key issues:

- 41-51 percent for handling the economy and jobs;
- 42 48 percent for handling the state budget;
- 39 50 percent for handling education.

"Gov. Christie's job approval numbers continue on the tepid track that started with the Bridgegate story, a dramatic contrast with the heady 2013 days when he was swooping to reelection," Carroll said.

U.S. Sen. Robert Menendez gets a 44-31 percent job approval rating, with 48-22 percent for U.S. Sen. Cory Booker.

### **Sports Betting**

There are large gender and age gaps as voters approve 51 - 43 percent allowing Garden State casinos and race tracks to take bets on professional and college sports. Men approve sports betting 64 - 31 percent, while women oppose it 54 - 39 percent.

Support is 63 - 31 percent among voters 18 to 34 years old, dropping to 55 - 40 percent among voters 35 to 54 years old. Voters over 55 years old are opposed 50 - 45 percent.

New Jersey should allow sports betting because of the economic benefits, 49 percent of voters say, while 44 percent say ban sports betting because it will compromise the integrity of professional and college sports.

From December 3 - 8, Quinnipiac University surveyed 1,340 registered voters, with a margin of error of  $\pm 2.7$  percentage points. Live interviewers call land lines and cell phones.
